Can you explain to me how I'm supposed to name the app so people understand what its purpose is?

LargeStreamingServiceWithAnS-To-LargeStreamingServiceWithAnA for example would not help much, would it?

i am honestly trying to understand what you would consider acceptable use in this case.

It would help me most if you could give me examples of alternative app names that did not infringe in your view, but DID help people actually find the app when they were in the position of wanting to convert their Spotify playlists to Apple Music.
